## **Counselor's Corner**

Dear DOES families,

What a great start to the school year it has been! Over the next month, the school counselors will be visiting classrooms to facilitate classroom lessons. Check out the grade-level newsletter that will go out for grade-specific information about the lesson from the school counselor! Additionally, we will continue to support all grades as needed through lunch, recess, and SEL support!

During SEL this week, students learned what regulation is and how it helps us. **Regulation** means being able to adjust or control something so it works well. Classes discussed different things they can regulate, such as the speed of a fan or the temperature of water. Students also explored how they can also regulate their body in a variety of ways such as eating a snack to regulate hunger, taking a nap to regulate being tired, putting on a jacket to regulate temperature, and using deep breathing to regulate feelings. Some things in our body are easier to regulate, while others take more time to learn.

Teaching about regulation is an important skill that helps us manage life's ups and downs. It supports our ability to work, to interact with others, and to feel more comfortable throughout our day.

To continue this learning at home you can go on a regulation-hunt at home to find things you regulate or adjust in your home. You can also discuss ways you regulate your body.

# Health & Safety Updates, Sept. 17, 2025

#### **Health Checks**

As the fall season gets underway and many activities move indoors, we often experience an increase in the spread of the flu, colds, COVID-19 and other communicable diseases.

All families, students, staff and visitors should conduct daily health checks prior to entering any HCPSS building and/or school bus, and are reminded to **stay home if they are experiencing symptom(s) associated with any communicable disease**.

Infection control prevents or stops the spread of infections, and may include standard precaution methods. Learn more about HCPSS protocols, how these conditions are managed at school, and how they can be handled at home. Additional information on keeping students healthy is available online.

# **Vaccination Clinics**

Due to extenuating circumstances, HCPSS <u>will not</u> offer in-school seasonal flu or COVID vaccination clinics this year. Parents/guardians are encouraged to contact their child's pediatrician for vaccination information, or consider accessing vaccinations from local pharmacies, urgent care centers, retail stores, etc. Additionally, the Howard County Health Department will offer free flu shots at various community events this fall.

# **Reporting Student Absences**

Students who are sick and need to stay home will be given an excused absence providing a note from the parent/guardian is submitted to the school after the student's return, indicating the date and reason for tardiness or absence from a regular school session. A doctor's note is required in cases of long-term absence or excessive absenteeism due to illness. If a student needs to stay home for a prolonged period due to illness, the student or a parent/guardian can reach out to their teacher(s) for resources students can use at home to continue learning once they feel well enough. Additional information on student absences can be found online.

Current residency documentation must be provided to the school each time residency changes. # Policy 9400 - Student Behavior Intervention

The Howard County Public School System (HCPSS) is committed to providing a safe, engaging, and supportive school environment that fosters the social and emotional safety, dignity, and well-being of all students. HCPSS acknowledges the need for employees to use an array of research-based positive behavior interventions, strategies, and a tiered system of supports to address student behaviors and keep students safe and free of harm to minimize the practice of exclusion from the classroom environment to minimize the use of physical restraint (which may only be used when necessary to protect a student or other person from imminent, serious, physical harm and only after other less intrusive, nonphysical interventions have failed or been determined inappropriate).

It is the expectation of the Board that HCPSS employees will be knowledgeable of and implement proactive positive behavior interventions in an effort to reduce the need for exclusion or physical restraint.

# <u>Policy 9460 - Bullying, Cyberbullying, Harassment, and Intimidation</u> Involving Students

Parents, Guardians, and Families,

The Howard County Public School System (HCPSS) is committed to providing a safe and nurturing environment for all students. Preventing bullying is an important part of this goal. HCPSS Policy 9460 states that bullying, cyberbullying, harassment, and intimidation are prohibited in HCPSS. Our administration and staff have been trained and made aware of this policy as well as preventative and responsive measures.

We know how important your role is in not only supporting your children, but also reporting possible incidents as you become aware of them. The Bullying, Cyberbullying, Harassment and Intimidation (BCHI Reporting Form should be used to report all alleged incidents of bullying, cyberbullying, harassment, and intimidation that occur at school or have a connection back to the school setting that create a risk of harm to other students while they are at school, or interfere with the educational environment. An <u>online version</u> is available and can easily and confidentially be used by students, staff, and family members. Hard copies of this form are available in the main office, staff workroom, school counseling office, media center, and health services office. If you believe your child has been bullied, please complete and submit this form as soon as possible and/or assist your child in doing so.

Once the form is submitted, school administrators will ensure the parent/guardian of both the alleged target and alleged offender are aware of the report and will begin an investigation within two school days of receiving the report. Parents/guardians can expect a school administrator to reach out to them during the investigation. Once the investigation is completed, parents/guardians will be provided written notice of the outcome of the investigation within fifteen days of receiving the complaint, excluding extenuating circumstances.

There are times when incidents of peer conflict or code of conduct offenses may occur that may not be bullying, but may need follow up action. If you become aware of something that falls under conflict and/or a code of conduct offense, please notify a school administrator via email or phone call so that they can become aware and follow up as needed.

Lastly, I want to take a moment to specifically lift up cyberbullying. Cyberbullying is bullying using electronic media like computers, cell phones, and game systems. Our digital interconnectedness makes bullying different and more damaging than it's ever been before. It allows hatred and publicly humiliating gossip or photos to be instantly far-reaching and inescapable as electronic media is everywhere. It can NOT simply be ignored. In October

2013, the State of Maryland enacted Grace's Law, making misuse of interactive computer services a criminal offense. Its purpose is to prohibit anyone from using electronic media (computers, tablets, phones, etc.) to maliciously engage in conduct that inflicts serious emotional distress on a minor and/or places that minor in reasonable fear of death or serious bodily injury. A person who is found guilty of violating this law is subject to imprisonment and/or fines.

While all of this information will be reviewed with students at school, we are asking you to do the same at home. Thank you for your partnership in ensuring all of our students feel a sense of safety and belonging in their school communities! ## **Student Personal Device Policy**

This summer, the Board of Education agreed to continue with the policy that implements strict limitations on the personal use of devices by students during the student day. Per the policy, students may be in possession of personal devices, but they must be "away and silenced," meaning devices are not able to be seen by either the student or staff member and are set to make no noise. Additionally, devices may not be a distraction. Smart watches will be permitted to be worn to check time but may not be a distraction. #### **Free and Reduced Meals**

Many families are eligible to participate in the Free and Reduced Price Meals (FARMs) Program, which provides children with a wide range of benefits including free or discounted college tuition, testing and application fees, program fees and many others. Families are urged to check their eligibility and complete a FARMs application as soon as possible. Families must submit a new application every school year. ## **Reminders About Arrival and Dismissal Procedures**

To ensure a smooth and safe arrival and dismissal for our students, please read the information below.

**SCHOOL HOURS:** 9:15 a.m. – 3:45 p.m.

#### **ARRIVAL TIMES:**

- 9:00 a.m. First bell rings/students may enter the building.
- 9:10 a.m. Second/late bell rings/students should be in the classroom.


Students should not be dropped off or let out of your vehicle until 9:00 a.m. Supervision is not available for students before this time. Before and after care is available through Howard County Parks and Recreation as well as other before and after school providers in the community.

All children who are late must be accompanied by a parent and be signed into school in the front office.

**DISMISSAL TIMES:** Dismissal begins at 3:45 pm.

If you have to make a change to your student's dismissal, please send a note and/or email to their teacher, and notify the front office. If you have to make a change during the day, after your student has arrived at school, please email your child's teacher AND email the front office staff at: <a href="mailto:doesfrontoffice@hcpss.org">doesfrontoffice@hcpss.org</a>. <a href="mailto:Doesfrontoffice@hcpss.org">No students will be released from the front office for early dismissal after 3:30pm</a>. This will help to ensure the safety of our students and cut down on confusion at the end of the day as afternoon dismissal begins.

**Arrival and Dismissal Procedures and Expectations:** Please see the visual below for the flow of our car loop. Below the visual are the expectations and instructions for making arrival and dismissal of your student(s) as efficient and safe as possible.



#### Reminders for arrival and dismissal:

Use the car loop to drop off students. When you enter the parking lot, you must make the full loop around.

- There is NO PASSING in the carpool loop, unless directed by a DOES staff member.
- Never leave a car unattended in the carpool loop/line.
- Pull up as far as possible (to the peninsula sidewalk) before letting your child exit the vehicle. Please make sure there are no spaces between cars.
- Children will be let out of the passenger side of the vehicle only. Staff will assist children with getting in and out of the car. Parents should NOT get out of the car.
- Do not turn left to enter the bus loop area between 8:45 a.m. and 9:15 a.m. or between 3:15 p.m. and 3:45 p.m.
- It is extremely unsafe to walk behind or between buses in the bus loop. Take the extra minute in line to ensure everyone's safety.
- Parents should avoid parking and walking in unless they have an appointment within the building. The car loop area is safer with less pedestrian traffic and fewer cars moving within the parking lot.
- If you need to park, you must park in the larger lot by the carpool loop. This is the only area with a crosswalk to ensure safety when walking toward the building.
- The parking spots parallel to Ten Oaks Road are designated as Staff Parking during arrival and dismissal. Entering or exiting your vehicle is unsafe from these parking spaces while traffic from the car loop is flowing.
- All traffic must flow in one direction.
- If you are leaving a parking spot during arrival or dismissal, follow the directions of school staff. You may need to wait for cars to continue through the car loop before you are directed to pull out of the lot. The priority is to keep the car loop flowing.
- Please be courteous and respectful to both staff and other families.

## **Health Room Reminders**

Any medications required during school hours including prescription, "over-the-counter" (OTC) and homeopathic/herbal medications require a medication order signed by an approved health care provider and are subject to the HCPSS medication policy and procedure.

School health room staff administer medications, store medications in the school's health room and keep records of when medications are taken by the student.

#### **Approved Non-Medications:**

The items below are not considered medications. Students may bring the items to school without a medical prescription. Health Services requests that a parent/guardian note accompany the item to serve as permission to bring to school.

- Sunscreen
- Chapstick
- Hand lotion
- Non-medicated cough drops
- Saline contact solution

Sunscreen must be supplied by an individual student and is not to be shared with other students due to potential allergens and skin reactions.

## **Attendance/Reporting Absences**

Parents can email <u>DOESabsence@hcpss.org</u> to report a student's absence. Please include your child(ren)'s full name, parent's/guardian's full name and phone number, the date your child(ren) was absent and the reason. Parents may instead choose to send in a paper excuse note to their child's teacher with the same information when the student returns to school.

For families requesting local discretionary absences, please complete a <u>Local Discretionary</u> <u>Absence Request Form</u> and submit it to the front office at least one week in advance.
