On Deck With Your Administrators

Dear Dayton Oaks Families:

We recognize that the federal government shutdown may be causing financial stress and uncertainty for many families in our Howard County Public School System (HCPSS) community. Please know that you are not alone, Dayton Oaks and the broader HCPSS community is committed to supporting every student and family during this challenging time.

Families who have experienced a loss of income due to the shutdown may apply for the Free and Reduced-Priced Meals (FARMs) program. The HCPSS Food and Nutrition Office will review applications and determine eligibility within 24–48 hours. Even families who did not previously qualify may now be eligible because of recent changes in income.

For families impacted, including those who do not receive FARMs assistance, any meal balances incurred during this time can be paid over the remainder of the school year. We want to ensure that all students continue to have access to nutritious meals without added stress for families.

We also recognize that children may be feeling worried or anxious, and some may even show signs of fear about their family's situation. Our Student Services staff at DOES are available to provide support during the school day, and [additional resources](#) are available for families on the [HCPSS website](#). [The Howard County Department of Community Resources and Services](#) also offers assistance to families in need.

During uncertain times, it is important to remember that we are a community that cares deeply

for one another. DOES staff are here to listen, help, and support you—please reach out if you or your family need assistance.

Counselor's Corner

At Dayton Oaks, we continue to focus school-wide on Zones of Regulation instruction. This month, students are learning the foundational idea that all feelings and all Zones are okay! Through this instruction, students are learning to accept their wide range of emotion and understand that their feelings will naturally change depending on situations. The work this month also introduces social awareness by showing children that different people can have different feelings and views in the same situation.

It is important to note that we are stressing to the students that while all feelings are okay, not all behaviors are okay. We emphasize the difference between an internal feeling and an external action. It is important to have safe behaviors for themselves and others. The Zones of Regulation curriculum is a tool for emotional learning and as students grow in their ability to regulate their feelings, they will also grow in their ability to regulate their behavior.

Students may have their portraits retaken on **Thursday, November 13, 2025**. If so, the entire original portrait package must be returned to the photographer on that day.

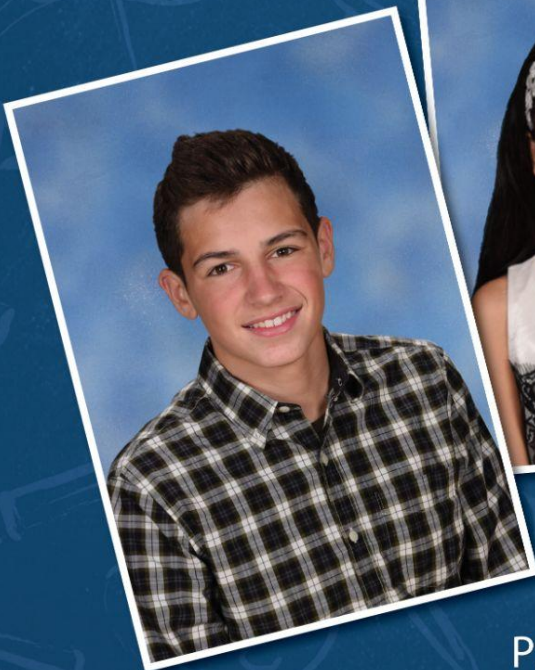

Quick Facts

What is LGBTQ+ History Month?

LGBTQ+ History Month was first established in 1994 by Rodney Wilson, a high school history teacher and former GLSN chapter leader. It was then declared a national history month by President Barack Obama in 2009. LGBTQ+ History Month is a month-long annual observance of lesbian, gay, bisexual and transgender history and the history of the gay rights and related civil rights movements. Taking the time to uplift and celebrate the achievements and accomplishments of the LGBTQ+ community plays a significant role in creating positive school climates for LGBTQ+ students.

Why October?

October was chosen to coincide with National Coming Out Day (October 11), International Pronoun Day (October 18), and the anniversary of the first March on Washington for gay and lesbian rights in 1979.

Language Updates

The LGBTQ+ acronym is used to refer to a diverse group of people with different sexual orientations and gender identities, and the "+" represents all the other identities that aren't explicitly included in the acronym. The acronym is used to be inclusive and to recognize that the understanding of gender and sexual identities is not monolithic. The meaning and evolution of the acronym will continue as more is learned about gender and sexual expression. Some communities may add additional letters to the acronym, especially if they are representing a community center or non-profit. For example, the Canadian government uses the acronym LGBTQ2, where the "2" stands for Two-spirit, a term used by some indigenous communities to represent gender and sexual diversity. ([source](#))

Even a quick stop in one of these spots can create real challenges. A child with limited mobility may not be able to get out safely, or a community member with a chronic health condition may find it difficult to make it safely to the building.

Choosing to leave these spaces available is not only the law, but also a thoughtful way to care for and support one another in our community. *This also means avoiding stopping behind the spaces in a way that blocks them.*

Free and Reduced Meals - Deadline to Apply is October 31st

Many families are eligible to participate in the Free and Reduced Price Meals (FARMs) Program, which provides children with a wide range of benefits including free or discounted college tuition, testing and application fees, program fees and many others. Families are urged to check their eligibility and complete a FARMs application as soon as possible. **The deadline to apply is Friday, October 31st.** Families must submit a new application every school year. Details on the [Free and Reduced Meals Program](#), including a link to apply, are available online.

Attendance

Research is clear that showing up for school has a huge impact on a student's academic and social success, starting from kindergarten and continuing through high school. Absences can be a sign that a student is losing interest in school, struggling with school, or even facing social challenges.

- Missing 10% (or about 18 days of a school year) can drastically affect a student's academic success.
- By the 6th grade, absenteeism is one of three signs that can indicate if a student is at risk for dropping out of high school.
- In the 9th grade, regular and high attendance predicts graduation rates better than 8th grade test scores.

Student attendance is a major point of focus for the Maryland State Department of Education (MSDE). Starting in the 2023-2024 school year, MSDE lowered the chronic absenteeism rate

from 20% to 10%, meaning that at 10%, a student should receive support and interventions to improve their absenteeism.

Howard County Public School System (HCPSS) believes that attendance is key to student success. Maryland's attendance rate represents the average daily attendance rate of students in grades 1-12, including special education students. The state's proficient standard for attendance rate is 94%, and the advanced standard is 96%."

In support of achieving Exemplary Attendance for all students, we are sharing with you a comprehensive approach to attendance supports and interventions.

- If a student has missed 5% of their monthly attendance days (as few as 1-2 days a month), parents/guardians will receive a Care and Concern Phone Call and letter from their school. This step will allow staff members to coordinate with families to determine how the student can be supported for better attendance.
- If a student has missed 10% of their monthly attendance days (this is defined as chronic absenteeism by MSDE), parents/guardians will receive a 10% Chronic Absenteeism Attendance Letter. Parents/guardians and students may be scheduled for an attendance conference. Other interventions and supports may also be used in an effort to assist the student.
- If a student has missed 15% of their monthly attendance days, in addition to the interventions and supports at 5% and 10%, these students may require an attendance support plan. Students may also be referred to the Central Attendance Team.
- If a student has missed 20% of their monthly attendance days, parents/guardians will receive a 20% Emergency Chronic Absenteeism Letter or Habitual Truancy Letter. Students may be referred to Project Attend and/or the State's Attorney's Office for habitual truancy.

With the collaborative effort of HCPSS parents/guardians, staff, and students, we are confident that all students can have successful attendance. This will improve student success in school and future life.

Health Checks

As the fall season gets underway and many activities move indoors, we often experience an increase in the spread of the flu, colds, COVID-19 and other communicable diseases.

All families, students, staff and visitors should conduct daily health checks prior to entering any HCPSS building and/or school bus, and are reminded to ***stay home if they are experiencing symptom(s) associated with any communicable disease.***

Infection control prevents or stops the spread of infections, and may include standard precaution methods. Vaccination Clinics

Due to extenuating circumstances, HCPSS **will not** offer in-school seasonal flu or COVID vaccination clinics this year. Parents/guardians are encouraged to contact their child's pediatrician for vaccination information, or consider accessing vaccinations from local pharmacies, urgent care centers, retail stores, etc. Additionally, the [Howard County Health](#)

Department will offer free flu shots at various community events this fall.

Change of Address

Please note that any change of residency must be reported through the Family File within 10 school days of the move. Current residency documentation must be provided to the school each time residency changes. Please reach out to the front office team with questions or if you need assistance with updating your Family File.

Student Personal Device Policy

This summer, the Board of Education agreed to continue with the policy that implements strict limitations on the personal use of devices by students during the student day. Per the policy, students may be in possession of personal devices, but they must be “away and silenced,” meaning devices are not able to be seen by either the student or staff member and are set to make no noise. Additionally, devices may not be a distraction. Smart watches will be permitted to be worn to check time but may not be a distraction. Reminders About Arrival and Dismissal Procedures

To ensure a smooth and safe arrival and dismissal for our students, please read the information below.

SCHOOL HOURS: 9:15 a.m. – 3:45 p.m.

ARRIVAL TIMES:

- 9:00 a.m. First bell rings/students may enter the building.
- 9:10 a.m. Second/late bell rings/students should be in the classroom.

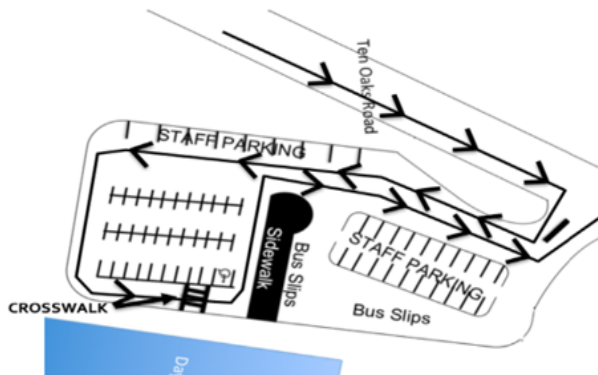
Students should not be dropped off or let out of your vehicle until 9:00 a.m. Supervision is not available for students before this time. Before and after care is available through Howard County Parks and Recreation as well as other before and after school providers in the community.

All children who are late must be accompanied by a parent and be signed into school in the front office.

DISMISSAL TIMES: Dismissal begins at 3:45 pm.

If you have to make a change to your student's dismissal, please send a note and/or email to their teacher, and notify the front office. If you have to make a change during the day, after your student has arrived at school, please email your child's teacher AND email the front office staff at: doesfrontoffice@hcpss.org. **No students will be released from the front office for early dismissal after 3:30pm.** This will help to ensure the safety of our students and cut down on confusion at the end of the day as afternoon dismissal begins.

Arrival and Dismissal Procedures and Expectations: Please see the visual below for the flow of our car loop. Below the visual are the expectations and instructions for making arrival and dismissal of your student(s) as efficient and safe as possible.



Reminders for arrival and dismissal:

Use the car loop to drop off students. When you enter the parking lot, you must make the full loop around.

- There is NO PASSING in the carpool loop, unless directed by a DOES staff member.

- Never leave a car unattended in the carpool loop/line.
- Pull up as far as possible (to the peninsula sidewalk) before letting your child exit the vehicle. Please make sure there are no spaces between cars.
- Children will be let out of the passenger side of the vehicle only. Staff will assist children with getting in and out of the car. Parents should NOT get out of the car.
- Do not turn left to enter the bus loop area between 8:45 a.m. and 9:15 a.m. or between 3:15 p.m. and 3:45 p.m.
- It is extremely unsafe to walk behind or between buses in the bus loop. Take the extra minute in line to ensure everyone's safety.
- Parents should avoid parking and walking in unless they have an appointment within the building. The car loop area is safer with less pedestrian traffic and fewer cars moving within the parking lot.
- If you need to park, you must park in the larger lot by the carpool loop. This is the only area with a crosswalk to ensure safety when walking toward the building.
- The parking spots parallel to Ten Oaks Road are designated as Staff Parking during arrival and dismissal. Entering or exiting your vehicle is unsafe from these parking spaces while traffic from the car loop is flowing.
- All traffic must flow in one direction.
- If you are leaving a parking spot during arrival or dismissal, follow the directions of school staff. You may need to wait for cars to continue through the car loop before you are directed to pull out of the lot. The priority is to keep the car loop flowing.
- Please be courteous and respectful to both staff and other families.

Health Room Reminders

Any medications required during school hours including prescription, “over-the-counter” (OTC) and homeopathic/herbal medications require a medication order signed by an approved health care provider and are subject to the HCPSS medication policy and procedure.

Medication form

School health room staff administer medications, store medications in the school’s health room and keep records of when medications are taken by the student.

Approved Non-Medications:

The items below are not considered medications. Students may bring the items to school without a medical prescription. Health Services requests that a parent/guardian note accompany the item to serve as permission to bring to school.

- Sunscreen
- Chapstick
- Hand lotion
- Non-medicated cough drops
- Saline contact solution

Sunscreen must be supplied by an individual student and is not to be shared with other students due to potential allergens and skin reactions.

Attendance/Reporting Student Absences

Students who are sick and need to stay home will be given an excused absence providing a note from the parent/guardian is submitted to the school after the student's return, indicating the date and reason for tardiness or absence from a regular school session. A doctor's note is required in cases of long-term absence or excessive absenteeism due to illness. Please email doesabsence@hcpss.org to report your child's absence.

If a student needs to stay home for a prolonged period due to illness, the student or a parent/guardian can reach out to their teacher(s) for resources students can use at home to continue learning once they feel well enough. Additional [information on student absences](#) can be found online.
