Effective Monday, Aug. 24 for the 2026-2027 school year, our new school hours will be 9:25 a.m. - 3:55 p.m. NOTE: There is no impact/change to this year's schedule.

Across the school district, three elementary schools will have adjusted start times. This is to ensure that all of our buses have sufficient time to complete their routes to school on time in the mornings and arrive at school on time for dismissal.

Changing school times may present an inconvenience to many parents/guardians as they adjust childcare and work schedules. I know all that goes into managing family schedules and appreciate your collaboration. Please know that this adjustment was carefully reviewed and is important to maintaining strong operations and we wanted to provide this information now so you have adequate time to prepare for the change in school hours.

Following the current school year, new times will be reflected on our school website and on any materials. I will continue to remind families about the new times this summer and leading up to the start of the 2026-2027 school year.

Early Childhood Classes

The Dayton Oaks Early Childhood Classes are making preparations for the upcoming 2026-2027 school year. Applications for general education students to participate as peers

through the **Learning Together Program (LTP)** are now available. These classes include general education and special education students. The program's focus is helping all children develop communication, literacy, math, problem solving, motor, and social skills. Parents of children who will be 3 by September 1st, may apply.

In alignment with [Maryland's Blueprint for the Future](#), **new applications for students turning 4 by September 1 are not available.** The Howard County Public School System continues to offer Prekindergarten for income eligible children who will be 4 years old by September 1. Early Childhood Programs

HCPSS offers a number of early childhood programs!

Learning Together Program (applications are currently open for students who will be 3 years old by 9/1/2026)



The Learning Together Program provides special education services for preschoolers with disabilities in classes that also include children who do not have disabilities. This program enables all young children to play with each other, develop long term friendships, and benefit from a diverse and stimulating environment, housed at various elementary schools across Howard County. Locations of early childhood programs for the upcoming school year are budget-pending and will be confirmed on June 15, 2025 or the last day of the current school year. Locations with available LTP programs will vary each year and are dependent upon space, staffing, and budget approval. Children are selected based upon screening information given on their application form and space availability. If necessary, a lottery process is conducted. Participation in the LTP requires a monthly fee. Families are required to provide their own transportation daily.

Pre-kindergarten (applications are currently open for students who will be 4 years old by 9/1/2026)



HCPSS offers high-quality, half- or full-day pre-k programs at selected sites. Students must be four years old on or before September 1, 2025 to be considered for the program. The HCPSS Pre-K program is made available first to children who will be 4 on or before September 1 and meet first priority criteria: income eligible, homelessness, and foster care. Unlike enrollment for K-12, parents must first apply and be accepted into the program before beginning online registration.

Kindergarten (registration is currently open for students who will be 5 years old by 9/1/2026)



Every child who is 5 years old by September 1 must be enrolled in a kindergarten program this fall or have an approved waiver.

River Hill Boosters Summer Camps

The River Hill High School Boosters are sponsoring summer camps at River Hill High School. The camps are designed to help young athletes improve their fundamental athletic skills. Weekly camps begin on June 8th. Over thirty different camps are offered this summer, including football, tennis, soccer, baseball, softball, lacrosse, field hockey, volleyball, basketball, cheerleading, weight training, cross country, “Hawks” Sports camp, and dance. HCPSS Summer Meal Program

HCPSS will offer its [free summer meal program](#) weekdays June 24-July 31 (except July 3) from 12:30-2 p.m. at locations across Howard County. Open to all HCPSS students and any children ages 18 and under, there are no applications, enrollment or fees to participate in this program, however children must be present to receive free meals. Free meals also will be provided to all students participating in HCPSS summer programs.

Application Open for HCPSS Prekindergarten

The application is open for HCPSS’ full-day prekindergarten program for the 2026-2027 school year. Families of children who turn 4 on or before September 1, 2026, are eligible to apply. [Additional information](#), including a link to the application, is available online.

Important School Calendar Updates

The Howard County Public School System (HCPSS) 2025-2026 school year calendar included three inclement weather makeup days, June 16–18. As of Feb. 26, HCPSS has used five inclement weather days and four late openings, resulting in high schools being two hours short of what is required in the Code of Maryland Regulations (COMAR).

At its February 26 meeting, the Howard County [Board of Education approved calendar adjustments](#) to ensure the school system meets the State's required days and hours, including:

- Tuesday, March 3: Scheduled as an early dismissal, becomes a full day for students.
- Monday, April 6 (Easter Monday): Scheduled as schools/offices closed, becomes a full day for students. The State Board of Education granted HCPSS a waiver to open school that day.
- Wednesday, April 15: Scheduled to be closed for students and designated as a staff professional learning and work day, becomes a half-day for students with the standard 3-hour early dismissal and half work day for staff.
- Thursday, May 14: Scheduled as an early dismissal, becomes a full day for students.
- Tuesday, June 16–Thursday, June 18: Scheduled as inclement weather makeup days included in the 2025-2026 school year calendar, become half days for students.

Barring any additional inclement weather days, the last day of school will be Thursday, June 18, 2026. Updates to the June calendar include the following:

- Thursday, June 11–Monday, June 15: Scheduled as early dismissals, become full school days
- Monday, June 15: Last day for half day pre-K / RECC .
- Tuesday, June 16–Thursday, June 18 (last day of school): Schools dismiss three hours early with half work days for staff. June 16 will be designated for staff articulation.

Any future disruptions to the calendar due to inclement weather will require additional solutions to be communicated if/when needed.

2026-2027 Kindergarten Registration

Kindergarten registration for families of children who will be 5 years old by September 1, 2026, kicked off Monday, March 2. Parents/guardians can begin the [enrollment process](#) online, after which your child's school will contact you to complete the registration process. Current HCPSS prekindergarten students do not need to be re-registered for kindergarten because they are already enrolled as an HCPSS student.

Reminders About Handicapped Parking Spaces

As our school days become busier, we want to extend a friendly reminder regarding arrival and dismissal procedures, in particular, the importance of respecting designated handicapped parking spaces.

Handicapped parking spaces are not just about convenience—they are a lifeline for students, staff, and families who need safe and accessible entry to our school.

Even a quick stop in one of these spots can create real challenges. A child with limited mobility may not be able to get out safely, or a community member with a chronic health condition may find it difficult to make it safely to the building.

We know drop-off and pick-up can be hectic, and we truly appreciate everyone's patience during those times. Choosing to leave these spaces available is not only the law, but also a thoughtful way to care for and support one another in our community. *This also means avoiding stopping behind the spaces in a way that blocks them.*

Thank you for helping us keep Dayton Oaks a safe, inclusive, and welcoming place for all. Please also share this reminder with any family members or friends who may be dropping off or picking up students.

Health Checks

As the winter season gets underway and many activities move indoors, we often experience an increase in the spread of the flu, colds, COVID-19 and other communicable diseases.

All families, students, staff and visitors should conduct daily health checks prior to entering any HCPSS building and/or school bus, and are reminded to ***stay home if they are experiencing symptom(s) associated with any communicable disease.***

Infection control prevents or stops the spread of infections, and may include standard precaution methods. Change of Address

Please note that any change of residency must be reported through the Family File within 10 school days of the move. Current residency documentation must be provided to the school each time residency changes. Please reach out to the front office team with questions or if you need assistance with updating your Family File.

Student Personal Device Policy

This summer, the Board of Education agreed to continue with the policy that implements strict limitations on the personal use of devices by students during the student day. Per the policy, students may be in possession of personal devices, but they must be "away and silenced," meaning devices are not able to be seen by either the student or staff member and are set to make no noise. Additionally, devices may not be a distraction. Smart watches will be permitted to be worn to check time but may not be a distraction. Reminders About Arrival and Dismissal Procedures

To ensure a smooth and safe arrival and dismissal for our students, please read the information below.

SCHOOL HOURS: 9:15 a.m. – 3:45 p.m.

ARRIVAL TIMES:

- 9:00 a.m. First bell rings/students may enter the building.
- 9:10 a.m. Second/late bell rings/students should be in the classroom.

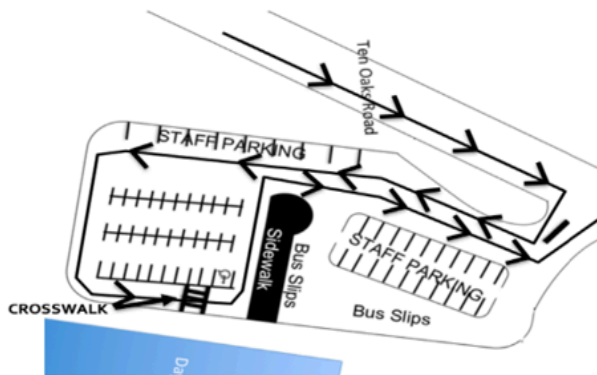
Students should not be dropped off or let out of your vehicle until 9:00 a.m. Supervision is not available for students before this time. Before and after care is available through Howard County Parks and Recreation as well as other before and after school providers in the community.

All children who are late must be accompanied by a parent and be signed into school in the front office.

DISMISSAL TIMES: Dismissal begins at 3:45 pm.

If you have to make a change to your student's dismissal, please send a note and/or email to their teacher, and notify the front office. If you have to make a change during the day, after your student has arrived at school, please email your child's teacher AND email the front office staff at: doesfrontoffice@hcpss.org. **No students will be released from the front office for early dismissal after 3:30pm.** This will help to ensure the safety of our students and cut down on confusion at the end of the day as afternoon dismissal begins.

Arrival and Dismissal Procedures and Expectations: Please see the visual below for the flow of our car loop. Below the visual are the expectations and instructions for making arrival and dismissal of your student(s) as efficient and safe as possible.



Reminders for arrival and dismissal:

Use the car loop to drop off students. When you enter the parking lot, you must make the full loop around.

- There is NO PASSING in the carpool loop, unless directed by a DOES staff member.
- Never leave a car unattended in the carpool loop/line.
- Pull up as far as possible (to the peninsula sidewalk) before letting your child exit the vehicle. Please make sure there are no spaces between cars.
- Children will be let out of the passenger side of the vehicle only. Staff will assist children with getting in and out of the car. Parents should NOT get out of the car.
- Do not turn left to enter the bus loop area between 8:45 a.m. and 9:15 a.m. or between

3:15 p.m. and 3:45 p.m.

- It is extremely unsafe to walk behind or between buses in the bus loop. Take the extra minute in line to ensure everyone's safety.
- Parents should avoid parking and walking in unless they have an appointment within the building. The car loop area is safer with less pedestrian traffic and fewer cars moving within the parking lot.
- If you need to park, you must park in the larger lot by the carpool loop. This is the only area with a crosswalk to ensure safety when walking toward the building.
- The parking spots parallel to Ten Oaks Road are designated as Staff Parking during arrival and dismissal. Entering or exiting your vehicle is unsafe from these parking spaces while traffic from the car loop is flowing.
- All traffic must flow in one direction.
- If you are leaving a parking spot during arrival or dismissal, follow the directions of school staff. You may need to wait for cars to continue through the car loop before you are directed to pull out of the lot. The priority is to keep the car loop flowing.
- Please be courteous and respectful to both staff and other families.

Health Room Reminders

Any medications required during school hours including prescription, “over-the-counter” (OTC) and homeopathic/herbal medications require a medication order signed by an approved health care provider and are subject to the HCPSS medication policy and procedure.

Medication form

School health room staff administer medications, store medications in the school’s health room and keep records of when medications are taken by the student.

Approved Non-Medications:

The items below are not considered medications. Students may bring the items to school without a medical prescription. Health Services requests that a parent/guardian note accompany the item to serve as permission to bring to school.

- Sunscreen
- Chapstick
- Hand lotion
- Non-medicated cough drops
- Saline contact solution

Sunscreen must be supplied by an individual student and is not to be shared with other students due to potential allergens and skin reactions.

Attendance/Reporting Student Absences

Students who are sick and need to stay home will be given an excused absence providing a note from the parent/guardian is submitted to the school after the student's return, indicating the date and reason for tardiness or absence from a regular school session. A doctor's note is required in cases of long-term absence or excessive absenteeism due to illness. Please email doesabsence@hcpss.org to report your child's absence.

If a student needs to stay home for a prolonged period due to illness, the student or a parent/guardian can reach out to their teacher(s) for resources students can use at home to continue learning once they feel well enough. Additional [information on student absences](#) can be found online.
