# Team Visits with Administrators

During the first three weeks of school, Ms. Williams-McKinney and Ms. Lorch visited all of the grade-level teams to discuss the <u>HCPSS Student Code of Conduct</u> and review the Dayton Oaks D.I.V.E. Expectations in developmentally appropriate and child-friendly ways. The HCPSS Student Code of Conduct provides a framework to support behavioral goals and disciplinary policies. While students are expected to be aware of and abide by this code, we all play a part in ensuring our school is a safe place where all students can learn. We look to partner with our families to support the social-emotional skill development of our students. Our D.I.V.E. expectations align with the HCPSS Student, Staff, Family and Community Commitments by providing descriptors to accompany the D.I.V.E. acronym:

- Completes tasks
- Makes trustworthy choices
- I Involved and Organized
  - Pays attention to learning tasks
  - Prepared materials

#### V - Very Respectful

- Works well with others
- Follows directions

#### E - Effortful

- Takes appropriate risks
- Demonstrates persistence

## Standards Based Instruction and Reporting (SBIR) Parent Night

Starting this school year, HCPSS will report student academic progress in grades PreK to 2 using standards-based reporting.

There are no changes to grade Grades 3-5 report cards. Intermediate grades will transition to standards-based reporting in 2024-2025.

## **Completing/Updating Family File**

We still have some families that have yet to complete their Family File. The Family File provides emergency contacts, and other important information for students. Completing your Family File also ensures that you are receiving information and updates from HCPSS and Dayton Oaks. This information must be updated every school year for every child. If you have already completed your Family File, we thank you! If you have not completed your Family File for the current school year, please follow the steps below:

Log in to <u>HCPSS Connect</u> using your parent/guardian credentials

- Select "More Options" from the left navigation
- Select "Family File" at the top of the page
- Complete <u>each</u> page of Family File
- On the last page, select the blue Submit button

Once logged in, parents/guardians will be asked to provide or update <u>all</u> of the following information:

- Student information
- Parent/guardian contact
- Emergency contacts
- Medical information
- Arrival/dismissal procedures
- Media release (photo approval)
- Data confidentiality
- PTA/PTSA directory

# Health Room Notes

#### **Getting Medication to School:**

Step 1 - Have your family physician complete an order form and submit it to your school.

- A new <u>Medication Order Form</u> is required for every new school year dated on or after July 1.
- All approved medication orders for the current school year are valid through summer school.
- School nurses will evaluate the physician order for appropriate dosage amount. If any area of the order form needs clarification, the nurse will consult your family physician.

#### Step 2 - Label the medication

Once approved, the parent can begin readying the medication for school use.

<u>Pharmacy Medications</u> - Pharmacy medications must be consistent with the medication order and properly labeled. Pharmacy containers and labeling are required. To make it easier on parents, a second labeled container for school use can be obtained from your pharmacist. Physician samples must also be appropriately labeled by the physician or parent. The following information must be on the label:

- Name of the student
- Date of the medication order
- Name of the medication
- Route, time and frequency of the medication
- Dosage and strength of the medication
- Authorized health care provider name

<u>Over-the-Counter Medications</u> - Over the counter medications must be received in new, unopened containers and be clearly labeled with the student's name.

Step 3 - Give a dose at home, drop off the medication

- The first dose of any new prescription coming to the school must be given at home 24 hours before coming to school.
- At the start of the school year, parents can drop off their student's medication at the school after giving the first dose 24 hours before coming to school. Students *cannot* bring their own medications to school.

**Step 4** - Monitor the medication during the school year

- Stopping the medication? Let your child's school know and then pick up the medication.
- Dose change? New medication? Parents have to submit a new order form.

<u>Expired Medication</u> - Within one week after expiration of the effective date on physician's order, the parent must personally collect the unused portion of the medication from the health room. Medication not claimed within that period will be destroyed.

At the end of the school year, all medications not picked up by the parent will be disposed of.

Many HCPSS families are eligible to participate in the <u>Free and Reduced Price Meals (FARMs)</u> program, which provides children with a wide range of benefits including free or discounted college tuition, testing and application fees, academic and athletic program fees and many others in addition to free or discounted meals. Families are urged to check their eligibility and complete a <u>FARMs application</u> as soon as possible. Families must submit a new application every school year.

## Outdoor Lunch Returns!!!

Beginning Tuesday, September 5, 2023, students will be able to participate in Outdoor Lunch during their lunch periods on a rotating basis. A tent is located adjacent to the background and blacktop that will support outdoor lunch. Teachers will be sharing outdoor lunch rotation schedules with families soon. As in years past, we can only offer outdoor lunch when a volunteer supports with supervision of students. Attached, please find the DOES Outdoor Lunch Volunteer Sign Up (SY 23-24). Please select days/times that fit your schedule. Each slot for outdoor lunch needs two (2) volunteers. In preparation for volunteering, please review updated HCPSS Volunteer Policies and Procedures here. Please bring proof of the completion of the Confidentiality Training Course as well as the Child Abuse Training course that is required of all volunteers when you come to Dayton Oaks. Submission of these documents are needed each school year. When you sign-in to volunteer (please bring your driver's license), please review the "TO DO" lists for Outdoor Lunch. You will also be given a name tag that must be worn at all times while on the DOES campus. Thank you for your efforts to keep our students safe. Our paraeducators are excited to welcome you to lunch and recess and are happy to provide you with direction and support related to your volunteer role as you may find that there are a few differences in procedures for different grade levels based on the developmental needs of our students. As always, if you have any questions regarding this wonderful volunteer opportunity, please let us know.

# Attendance/Reporting Absences

Parents can email <u>DOESabsence@hcpss.org</u> to report a student's absence. Please include your child(ren)'s full name, parent's/guardian's full name and phone number, the date your child(ren) was absent and the reason. Parents may instead choose to send in a paper excuse note to their child's teacher with the same information when the student returns to school.

For families requesting local discretionary absences, please complete a <u>Local Discretionary</u> <u>Absence Request Form</u> and submit it to the front office at least one week in advance.

## **Bullying Prevention**

The Howard County Public School System (HCPSS) is committed to providing a safe and nurturing environment for all students. Preventing bullying is an important part of this goal. HCPSS Policy 9460 states that bullying, cyberbullying, harassment, and intimidation are prohibited in HCPSS. The BCHI Reporting Form should be used to report all alleged incidents of bullying, cyberbullying, harassment, and intimidation that occur at school or have a connection back to the school setting that create a risk of harm to other students while they are at school, or interfere with the educational environment. An online version is available and can easily and confidentially be used by students, staff, and family members. Hard copies of this form are available in the main office, staff workroom, school counseling office, media center, and health services office. If you believe that a student has been bullied, please complete and submit this form as soon as possible.

Once the form is submitted, school administrators will ensure the parent/guardian of both the alleged target and alleged offender are aware of the report and will begin an investigation within two school days of receiving the report. Parents/guardians can expect a school administrator to reach out to them during the investigation. Once the investigation is completed, parents/guardians will be provided written notice of the outcome of the investigation within fifteen days of receiving the complaint, excluding extenuating circumstances.

We want to take a moment to specifically lift up cyberbullying. Cyberbullying is bullying using electronic media like computers, cell phones, and game systems. Our digital interconnectedness makes bullying different and more damaging than it's ever been before. It allows hatred and publicly humiliating gossip or photos to be instantly far-reaching and inescapable as electronic media is everywhere. It can NOT simply be ignored. In October 2013, the State of Maryland enacted Grace's Law, making misuse of interactive computer services a criminal offense. Its purpose is to prohibit anyone from using electronic media (computers, tablets, phones, etc.) to maliciously engage in conduct that inflicts serious emotional distress on a minor and/or places that minor in reasonable fear of death or serious bodily injury. A person who is found guilty of violating this law is subject to imprisonment and/or fines. While this will be reviewed with students at school, we are asking you to do the same at home. Thank you for your partnership.
